Committee Chair, David Kidd, welcomed members and called the virtual meeting to order at 2:03pm.

Approve 04/11/2022 Agenda – Judge Joe Bishop moved to approve the Agenda. Motion seconded by Cindy Levi and carried without opposition.

Approve 03/07/2022 Committee Meeting Minutes –Alecea Quintyne moved to approve the minutes. Motion seconded by Judge Joe Bishop and carried without opposition.

Legislative Updates – Devin Krecl gave an update on the Legislative Session that ended on Monday, April 4, 2022, which included the passing of the following bills:

- HB1013- The Mental Health Parity Act
- HB752- The Psychiatric Advance Directive
- SB403- Georgia Behavioral Health and Peace Officer Co-Responder Act

Devin stated that both HB752 and SB403 are still awaiting signature, but he would let the group know when the signing dates have been released. SB610, DCH Review of Provider Reimbursement Rates, the DBHDD Budget, and why several private providers were funded directly within the DBHDD section of the FY23 Budget v/s CSBs was discussed by the group. Devin Krecl suggested additional branding and strategic marketing of the CSBs should be a priority of the Committee.

Behavioral Health Reform and Innovation Commission – Cindy reported that no sub committees have met since the last Public Image and Policy Committee meeting, but with the Legislative Session now at a close, they should be meeting in the next month or two.

Strategic Plan Discussion/Update- Robyn Garrett shared the Revised CSB Region Map with the group. There was discussion amongst the group about the concern with having leadership personal email addresses on the back of the map. June DiPolito asked the Executive Office to remove her direct extension number from the Pineland CSB listing. Potential ideas such as having two different print outs (Legislative and Public) was discussed by the group. It was decided that the group would present the map and CSB Directory to the CEOs during the next CEO Weekly Meeting on April 14, 2022, for further discussion.

Other- Robyn Garrett stated that Magellan Healthcare is hosting a Children's Mental Health Summit on May 4th which kicks off Children's Mental Health Week at The Carter Center. PIP and Executive Committee have authorized GACSB participation as an exhibitor at this free event. Jesse Hambrick and Renee Millians will be manning a booth at the event.
