High Level Summary	
	The upcoming board meeting on 10/8 will feature strategic plan presentations from all committee chairs; preparations are on track, and final checks will be made before the meeting.
	The meeting with Commissioner Tanner, originally scheduled for October 27 (during the conference), has been requested to move to early November; date to be determined pending commissioner availability.
	There is a need to collect and email suggested topics for the commissioner and for his state of the state presentation at the conference; topics should be submitted within the next week. Reminders were issued for members to complete donation forms for event prizes; a shout-out will be sent to CSBs recognized and for recent grand openings.
	Several CSBs are overdue on dues (seven remain after recent payments); a review with Kathy is scheduled, and targeted reminders will be sent. Overdue amounts are being tracked by age and type (including annual dues, SPQM, and National Council charges).

	Members report inaccurate capacity figures, complex reporting requirements, and difficulties with denial reasons, queue management, and system glitches. There is a need for clarity and alignment across regions regarding data sources, calculation timing, and valid denial reasons.
Action Items	 Submit any proposed topics for the commissioner's state of the state presentation via email by next week. Ensure donation forms for event prizes are completed and submitted. Board to discuss handling of old dues from merged/dissolved CSBs. Add Select Systems' future to the board meeting agenda and consider scheduling an in-person strategy session. Continue tracking bed board issues at each unit and escalate to leadership for unified problem-solving and resolution.
